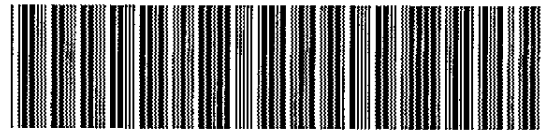

David L. Barnette

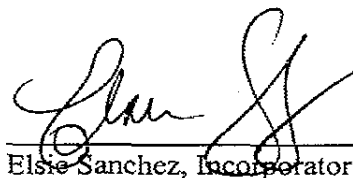
