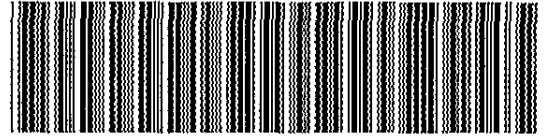



ARTICLES OF INCORPORATION
OF

AFFORDABLE SITE CLEANING, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is Affordable Site Cleaning, Inc.

ARTICLE II

The existence of the Corporation shall begin upon the filing of the articles of incorporation.

ARTICLE III

The street address of the principal office of the Corporation is 3215 13th St. E., Bradenton, FL 34208.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 500, par value \$1.00 per share, all of which shall be voting Common Shares. 
