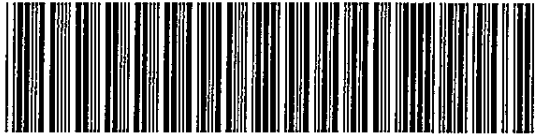

ARTICLE I

NAME OF CORPORATION

The name of the Corporation is Angela Hanif Corporation.

ARTICLE II

The principal office of the Corporation is located at 1491 S. Rio Grande Ave., Orlando, FL 32805.

ARTICLE III

The street address of the initial registered agent of the Corporation is 2231 Settlers Trail, Orlando, FL 32837, and the initial registered agent at that address is Mohammad Hanif.

ARTICLE IV

The general nature of the business to be transacted by the corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE V

The affairs of this Corporation shall be managed initially by a Board of one (2) Directors. The number of Directors may be changed by amendment of the by-laws of the Corporation.
