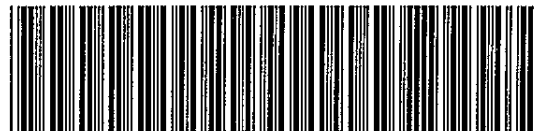

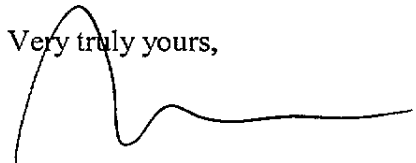

ARTICLE I - NAME

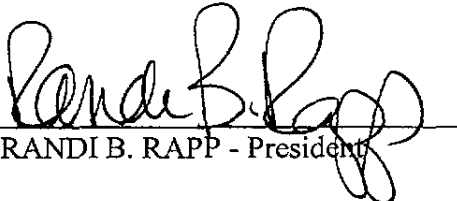
The name of the corporation shall be LIST4LESSONTHEMLS.COM, INC.
