ARTICLE I: CORPORATE NAME

The name of this Corporation is **Nursing Care First, Inc.**, and its mailing address is, **2625 State Rd. 590, Apt. 1332, Clearwater, FL 33759.**

ARTICLE II: NATURE OF BUSINESS

This Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is **100** shares of common stock having par value of one (**\$1.00**) dollars.

ARTICLE IV: TERM OF EXISTENCE

This Corporation shall have perpetual existence commencing upon the filing of these articles.

**ARTICLE V:


ARTICLE X: PRE-EMPTIVE RIGHTS
