

**ARTICLES OF INCORPORATION
OF
SAR OF PINELLAS, INC.**

The undersigned, acting as Incorporators of a corporation under the Florida General Corporation Act, adopt the following ARTICLES OF INCORPORATION for such corporation:

ARTICLE I. NAME

The name of this corporation is **SAR OF PINELLAS, INC.**

ARTICLE II. DURATION

The period of its duration is perpetual.

ARTICLE III. PURPOSE

This Corporation is organized to perform any act and deed that is legal and is permitted by the laws of the United States and the State of Florida and any other state in which the corporation might choose to conduct business.

ARTICLE IV. CAPITAL STOCK

This Corporation is authorized to issue 100 shares of stock at \$5.00 per share.

ARTICLE XI. 1244 ELECTION


