**ARTICLE OF INCORPORATION
OF

The undersigned, being a natural person, competent to contract and licensed to practice nursing in the State of Florida, acting hereby as incorporator for the purpose of establishing a Professional Service Corporation under the provisions and subject to the requirements of the laws of the State of Florida, particularly Chapter 607, Florida General Corporation Act and the acts amendatory thereof and supplemental thereto, does hereby adopt and make the following Articles of Incorporation and does hereby certify that:

ARTICLE I - NAME

The name of the corporation (hereinafter called the "Corporation") is:

ARTICLE II - PURPOSE

The general nature of the business or businesses to be transacted by the Corporation, which shall include the authority of the United States or of the State of Florida for which Corporations may be incorporated under Chapter 607 and 621, Florida Statutes, and supplemented, is as follows:

- (a) To engage in every aspect of being a Nurse Practitioner and all its fields of specializations, as are engaged in and regulated by the Board of Nursing in the State of Florida.
- (b) To do everything necessary and proper in accomplishing the purpose herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

ARTICLE III - POWERS

The Corporation shall have all of the powers conferred upon corporations organized pursuant to the provisions of Chapters 607 and 621, Florida Statutes, as amended and supplemented.

ARTICLE IV - CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share. Shares of the corporation's common stock shall only be issued to persons in the same licensure category.

The Corporation is to have perpetual existence unless dissolved by law.
