The name of the corporation is: BIZTEX USA, INC.



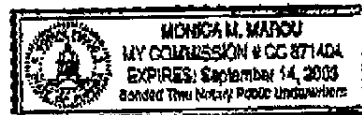
