ARTICLES OF INCORPORATION
OF

WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be:

DUVAL, INC.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

The total number of shares of capital stock which may be issued by this corporation is SEVEN THOUSAND FIVE HUNDRED (7,500) SHARES of common stock having a par value of ONE (\$1) DOLLAR per share, all of which shall be common stock and shall be fully paid and non-assessable. All such stock shall be payable in cash, property, labor or services at a just valuation to be

fixed by the board of directors at a meeting called for that purpose.

ARTICLE IV

The amount of capital with which this corporation shall commence business is FIVE HUNDRED (\$500) DOLLARS capital money paid in.

ARTICLE V

The highest amount of indebtedness to which this corporation may obligate itself will be ONE HUNDRED MILLION (\$100,000,000) DOLLARS.
