## ARTICLES OF INCORPORATION

CONTRACTOR OF THE PARTY OF THE

WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws
of the State of Florida, providing for the formation, liability,
rights, privileges and immunities of a corporation for profit.

### ARTICLE I

The name of the corporation shall be:

## ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

### ARTICLE III

The total number of shares of capital stock which may be issued by this corporation is SEVEN THOUSAND FIVE HUNDRED (7,500) SHARES of common stock having a par value of ONE (\$1) DOLLAR per share, all of which shall be common stock and shall be fully paid and non-assessable. All such stock shall be payable in cash, property, labor or services at a just valuation to be
