

THE UNDERSIGNED, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

WITNESSETH;

ARTICLE I <u>Name</u>

The name of the Corporation is: M.A. STUDIOS, INC.

The Principal Office is: 3555 W. Hillsboro Boulevard Deerfield Beach, FL 33442

ARTICLE II Duration

This Corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State of Florida.

ARTICLE III Purposes

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV Capital Stock

This Corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE V Ouorum for Stockholders Meetings
