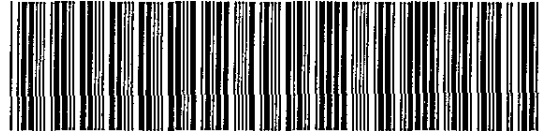

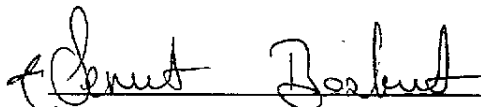
ARTICLE IX - AMENDMENT
