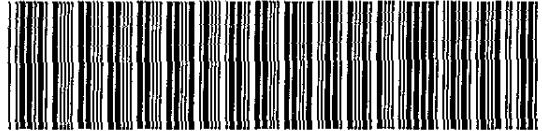

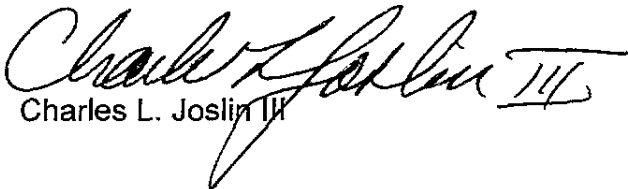

The undersigned, for the purposes of forming a for-profit corporation under the laws of the State of Florida, adopts the following articles of incorporation.

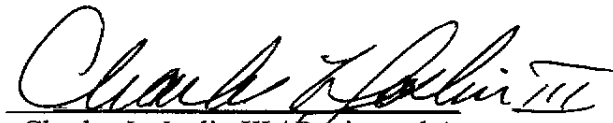

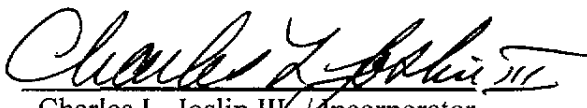
