The undersigned, who is duly licensed to practice medicine in the State of Florida, desiring to form a professional corporation in accordance with Chapter 621 of the Florida Statutes, and the Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Corporation:

Article 1. Name

The name of the Corporation is:

The primary purpose for which the Corporation is organized is to practice medicine. Article 12. Amendment


