The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be: **TJR SERVICES, INC.**

**ARTICLE II. ADDRESS**

The address of the principal office of this corporation shall be 4201 Johnston Road, Fort Pierce, FL 34951, and the mailing address of the corporation shall be the same.

**ARTICLE III. NATURE OF BUSINESS**

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
