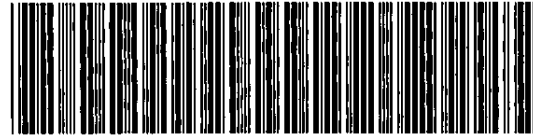




RESOLVED: This Board of Directors hereby removes Mina Farahbakhsh of the position of Treasurer.
