ARTICLES OF INCORPORATION
OF

I. NAME

The name of the corporation is MARCO 4, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.


IX. SUBSCRIBER AND INCORPORATOR

X. AMENDMENTS

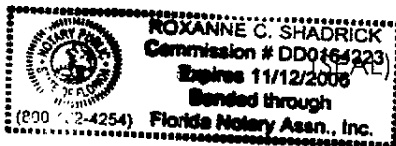




