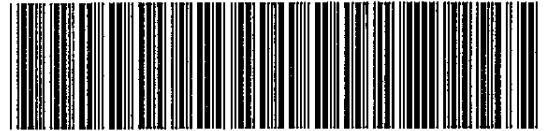

This corporation shall exist perpetually commencing on the date of execution and acknowledgement of these Articles by the state of Florida.


ARTICLE VI


AMENDMENTS


