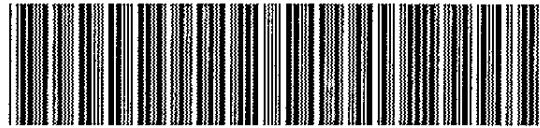

**ARTICLES OF AMENDMENT TO ARTICLES OF  
INCORPORATION OF  
SUN STATE TRUCK BROKERS, INC.**

The undersigned, being the sole incorporator of SUN STATE TRUCK BROKERS, INC., a Florida corporation that has not yet issued shares of stock, hereby amends the Articles of Incorporation filed on January 22, 2003, pursuant to §607.1005 and 6007.1006, Florida Statutes, as follows:

**ARTICLES VI: DIRECTORS**

The number of directors of the Board of Directors may be increased or decreased from time to time by changes to the corporate By-Laws but shall never be less than three (3).
