

The ARTICLES OF INCORPORATION of UR-WAY TOW AWAY, INC., are as follows:

**ARTICLE I.**

The name of this corporation shall be UR-WAY TOW AWAY, INC.

**ARTICLE II.**

The duration of this corporation is perpetual.

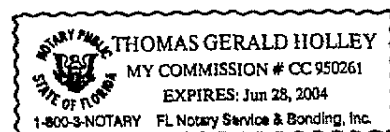
