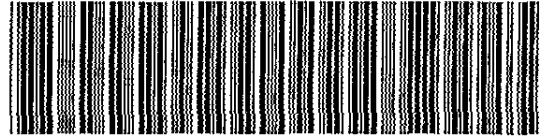

OF


