## ARTICLES OF INCORPORATION OF Successful Development, Inc.

(Pursuant to Chapter 607 and/or 621, Florida Statutes)

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

## Article 1. Name

The name of the corporation is Successful Development, Inc., a Florida Corporation.

## Article 2. Duration

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department.

## Article 3. Purpose

EFFECTIVE DATE


