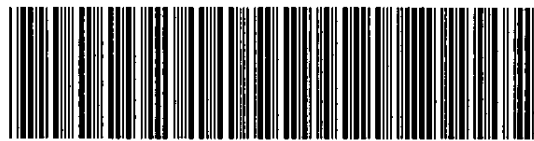

The name of the corporation is Sago Island, Inc. ("Corporation").

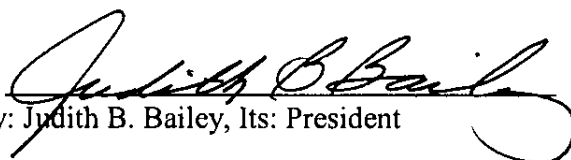
ARTICLE II - DATE AUTHORIZED
