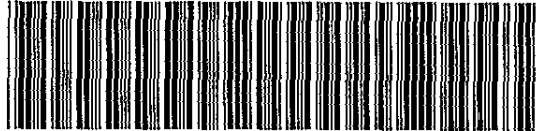

THE UNDERSIGNED, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**  
**NAME**

The name of the corporation shall be SUBWAY RNS, Inc. The principal office of the corporation is 3863 Northwest 7 Place, Deerfield Beach, Florida 33442 and the mailing address of the corporation is 3863 Northwest 7 Place, Deerfield Beach, Florida 33442.

**ARTICLE II**  
**DURATION**

The term of existence is perpetual.

**ARTICLE III**  
**CAPITAL STOCK**

The aggregate number of shares which the corporation has authority to issue is 1,000 shares and each share shall be the par value of \$1.00. 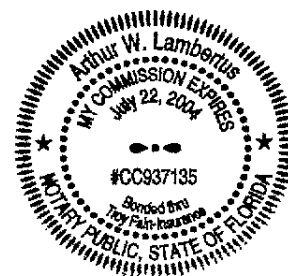
