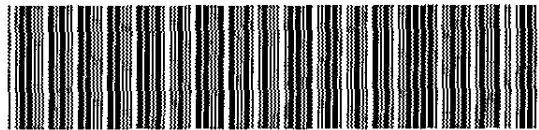



ARTICLE I - NAME

The name of this corporation is NALDA REHABILITATION SERVICES, INC.

ARTICLE II - ADDRESS
