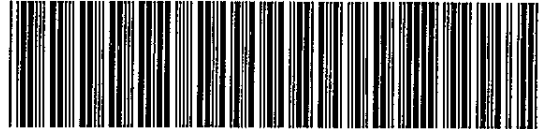

1. The name of the Corporation is THE OLDE BOARDING HOUSE INC.

2. Article III of the Articles of Incorporation of THE OLDE BOARDING HOUSE INC. is amended to read as follows:

ARTICLE III

CAPITAL STOCK

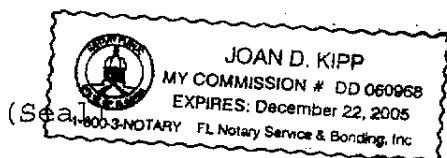
