ARTICLE I.

NAME

The name of the Corporation is **GLOBAL WEST USA CORPORATION**

ARTICLE II.

TERM OF CORPORATE EXISTENCE

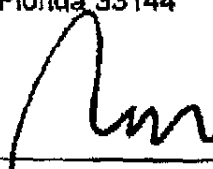

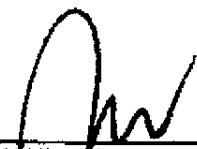

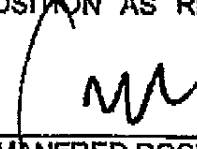
