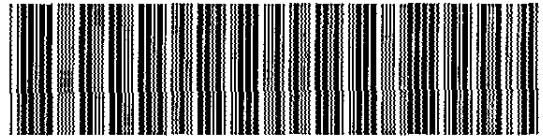

ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of **WORKING IT RIGHT REHAB, INC.**, a Florida corporation, under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is **WORKING IT RIGHT REHAB, INC.**

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE

The corporation shall have at least one director. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one.

ARTICLE VIII. INCORPORATOR
