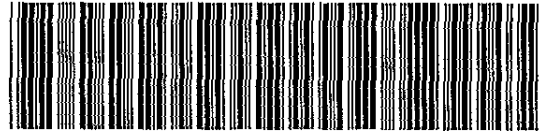

ARTICLES OF INCORPORATION  
OF

QUICK RECOVERY CORP

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is - QUICK RECOVERY CORP

ARTICLE II

The existence of the Corporation shall begin on DATE OF FILING.

ARTICLE III

The street address of the principal office of the Corporation is 8020 S.W. 162ND STREET, MIAMI, FLORIDA 33156

ARTICLE IV
