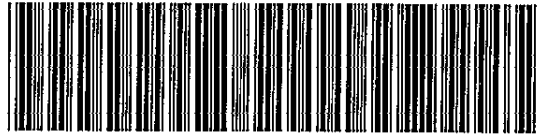

ARTICLE VI - POWERS OF CORPORATION


