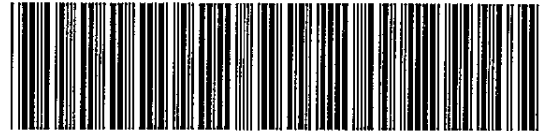

without a Meeting:


The Directors and Stockholders of this Corporation may take action by written consent, as provided by law and the By Laws of this Corporation.




