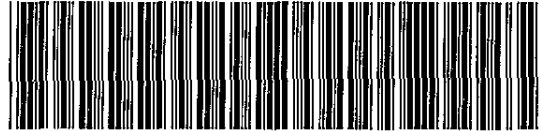

The number of shares of stock that this corporation is authorized to have outstanding at any one time is four shares having no par value.


Article IV: Special Provisions


Article VI: Certificate Designating Registered Agent/Registered Office
