Under the provisions of the laws of the State of Florida, the undersigned subscriber to these Articles of Incorporation hereby affirms his/her competency to contract and hereby forms a corporation under and pursuant to the Florida Business Corporation Act.

**ARTICLE I: Corporate Name**

The name of this corporation shall be **BLACK & WHITE CONSTRUCTION, Incorporated** having as its principal place of business **2913 WALNUT STREET TAMPA, FLORIDA 33607-3205.**

**ARTICLE II: Nature of Business**

This corporation may engage in, transact, contract, be a party to and/or become involved in any and all lawful activities, ventures or business arrangements permitted under the current or future laws, statutes or ordinances of the United States of America, the State of Florida, or any other state, country, territory, parish, city or nation.

**ARTICLE III: Capital Stock**

The maximum number of shares of common stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED (100); each share having a par (stated) value of ONE DOLLAR (\$1.00), payable in lawful and legal tender of the United States of America. Said stock shall be issued in units of one share or multiples thereof. 
### **ARTICLE VIII: Amendments**

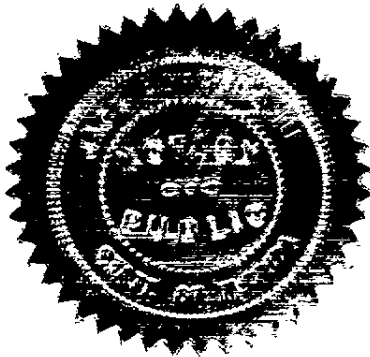
