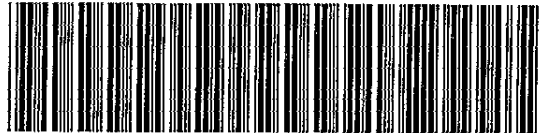

**THIS IS TO CERTIFY** that we, the undersigned, for the purpose of forming a corporation under the provision of Florida Statutes 1985, Chapter 607, and statutes amendatory thereof and supplementary thereto, do hereby make, subscribe, acknowledge and file these Articles of Incorporation, as we do certify that:

- 1. The name of the corporation is: EDEL OJEDA, INC.**
- 2. The major purpose of the corporation will be to engage in the business of cabinet installations.**

**In addition, the general nature of the business transacted shall be:**

**To engage in any one or more of the businesses and to exercise any and all powers authorized and permitted by the said statutes to corporations formed thereunder.**

**Furthermore, and not by way of limitation of the preceding paragraph, to enter into and perform contracts of every kind and nature; to act as agent and representative of other persons and corporations; to own, buy, sell, mortgage or lease real and personal property of every kind and nature and wheresoever situate.**

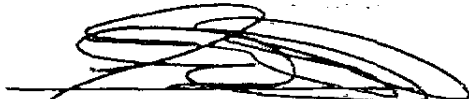

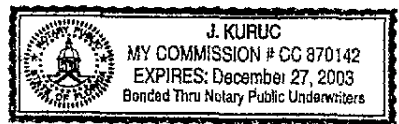
