#### ARTICLES OF INCORPORATION

#### ARTICLE I - NAME:

The name of this corporation is: STEVENSON REALTY, P.A., hereinafter referred to as the "Corporation".

#### ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

#### ARTICLE III - PURPOSE:
