

ARTICLE I

The name of this corporation is ADVANCED SECURITY AUTOMATIONS, INC. Whose principal address is 9108 N.W. 73 Street, Tamarac, Florida 33321

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in the alarm installation and service, a business permitted under the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.


