The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

#### ARTICLE I

Name

The name of the corporation is RALEY MANAGEMENT SERVICES, INC.

### ARTICLE II Principal Office
