The name of this corporation is 3D ELECTRIC, INC.

Maria G. Gonzalez - Vice President.

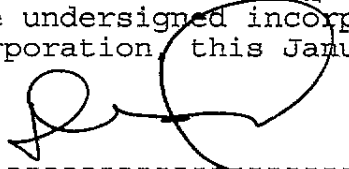
ARTICLE VIII - BEGINNING OF CORPORATE EXISTENCE

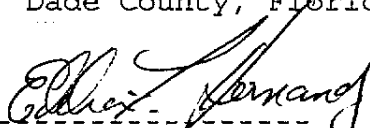

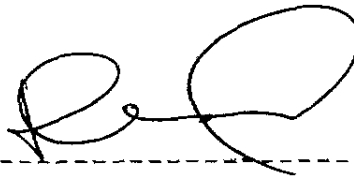
