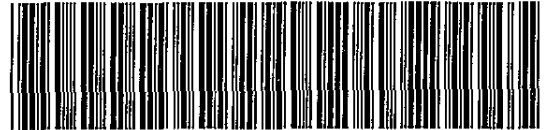

ARTICLES OF INCORPORATION
OF
SHAWNA JACKSON, D.V.M., P.A.

The undersigned subscriber to these Articles of Incorporation of a Professional Service Corporation, a natural person competent to contract, and admitted to practice as a veterinarian under the laws of the State of Florida, does hereby form a Professional Service Corporation under the laws of the State of Florida.

Article I

Name. The name of this Corporation is Shawna Jackson, D.V.M., P.A.

Article II

Principal Office. The address of the principal office of the Corporation is 4337 N.W. 35th Terrace, Gainesville, Florida 32605.

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV

Purpose. The nature of the business to be transacted by this Professional Service Corporation and the purpose thereof is to render professional veterinary services to the general public and to do all things in connection therewith that are customarily done by licensed veterinarians under the laws of the State of Florida, and in accordance with the "Professional Service Corporation Act," Chapter 621 of the laws of Florida, to invest funds in real estate, mortgages, stocks, bonds and other types of investments, and not limiting the acquisition of life insurance bonds, debentures, commodities, leaseholds, options, puts and calls, easements, mortgages notes, mutual funds, investment trusts, common trust funds, voting trust certificates, and any class of stock or right to subscribe for stock, including trading on margin. The Corporation may own real or personal property necessary for the rendering of professional services. The Corporation shall not engage in any business other than the practice of veterinary medicine.

Article V

Capital Stock. This Corporation is authorized to issue 1,000 shares of \$.01 par value common stock.

Article VI

By-Laws. The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and Shareholders.

Article VII

Initial Registered Office and Agent. The street address of the initial registered office of this Corporation is 4337 N.W. 35th Terrace, Gainesville, Florida 32605, and the name of the initial registered agent of this Corporation is Shawna Jackson, D.V.M.


Article VIII

Initial Board of Directors. The Corporation shall have one (1) Director initially. The number of Directors may either be increased or diminished from time to time by the By-Laws, but it shall never be less than one. The name and address of the initial Director of this Corporation is Shawna Jackson, D.V.M., 4337 N.W. 35th Terrace, Gainesville, Florida 32605.

Article IX
