

### ARTICLES OF INCORPORATION JEUNETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned subscriber to these Articles of Incorporation of a Professional Service Corporation, a natural person competent to contract, and admitted to practice as a veterinarian under the laws of the State of Florida, does hereby form a Professional Service Corporation under the laws of the State of Florida.

#### Article I

Name. The name of this Corporation is Shawna Jackson, D.V.M., P.A.

#### Article II

*Principal Office.* The address of the principal office of the Corporation is 4337 N.W. 35<sup>th</sup> Terrace, Gainesville, Florida 32605.

#### Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

#### Article IV

Purpose.
