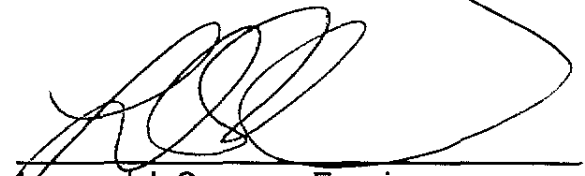

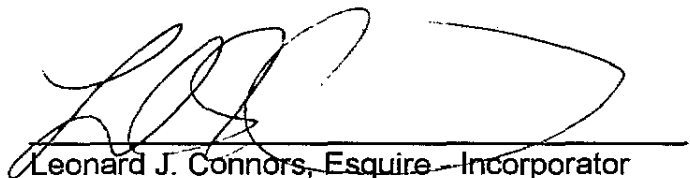
ARTICLE XI INDEMNIFICATION
