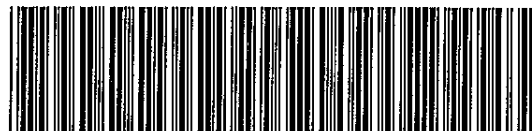

ARTICLES OF INCORPORATION

OF

ARTICLE I - Name

The name of this corporation is Nick Pucek Realty, Inc.
