ARTICLES OF INCORPORATION
OF
ELT ENTERPRISES, INC.

The Undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1.0 NAME AND ADDRESS

The name of the Corporation is: ELT Enterprises, Inc. The principal office and mailing address is 7157 Glendyne Drive South, Jacksonville, Florida 32216.

ARTICLE 2.0 DURATION

The duration of the Corporation is perpetual.

ARTICLE 3.0 PURPOSE

The general purpose for which the Corporation is organized is to engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

ARTICLE 4.0 SHARES

The aggregate number of shares which the corporation is authorized to issue is **One Hundred Thousand (100,000)** shares of common stock. Such shares shall be of a single class and shall have a par value of **\$0.01/100 per share**.

ARTICLE 5.0 INITIAL REGISTERED OFFICE AND AGENT



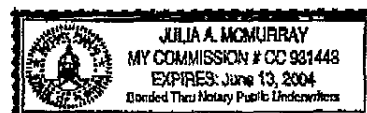


