The undersigned subscribes to these Articles of Incorporation, each a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I

NAME: The name of this corporation is:

V & V ARTISTIC DESIGN, INC.

#### ARTICLE II

#### NATURE OF BUSINESS:

- (a) The general nature of the business of the corporation to be conducted by the corporation shall be to be engaged in the design & construction of furniture in general.
