SCOTTSOUND, INC.

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I: NAME**

The name of the Corporation shall be: SCOTTSOUND, INC.

**ARTICLE II: PRINCIPAL OFFICE**

The principal office of the Corporation shall be located at 2201 Seventh Street North, St. Petersburg, Fl. 33704-3329 but the Corporation shall have power to establish branch offices and other places of business at such other places within or without the State of Florida, as may be determined and deemed expedient by the Directors.

**ARTICLE III: CAPITAL STOCK**

The capital stock of the Corporation shall be divided into shares of \$1.00 par value, with 7500 shares of common stock authorized, and each share shall entitle the holder thereof to vote at any meeting of the stockholders.
