

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF

PHYSICIANS INSURANCE COMPANY

Pursuant to the provisions of Section 607.1006, Florida Statutes, the Corporation hereby amends its Articles of Incorporation as follows:

FIRST: The Text of Article IV of the Articles of Incorporation is hereby amended, in whole, to read as follows (the "Amendment"):

The maximum number of shares this corporation is authorized to issue is 500,000 shares of common stock having a par value of \$6.25 per share. The common shares shall have unlimited voting rights, with each share being entitled to one vote, and the right to receive the net assets of the corporation upon dissolution, with each share participating on a pro rata basis. The corporation shall not begin transacting business unless it achieves a capital surplus of \$5 Million. The consideration received as surplus for any shares may consist of any type of securities in which the corporation would be permitted to invest under the Florida Insurance Code.

SECOND: The Corporation shall not be required to take further action to implement the Amendment. The Corporation is authorized to undertake such measures as are reasonable to evidence the effect of the Amendment if the Corporation deems it necessary to do so; which measures may include, but need not be limited to: the replacement or amendment of any stock certificates of the Corporation; notification of shareholders of record, as of the effective date of the Amendment, of the Board's adoption of the Amendment; or such other measures as are not inconsistent herewith.

THIRD: The Amendment shall be effective as of December 5, 2017.

FOURTH: These Articles of Amendment have been approved by the Board of Directors by adoption on the 5th day of December, 2017, and approved by the Texas Medical Liability Trust, the sole shareholder of the Corporation on the same date.

FIFTH: The undersigned officer of the Corporation has been authorized by the Board of Directors to execute these Articles of Amendment and cause the filing thereof.
