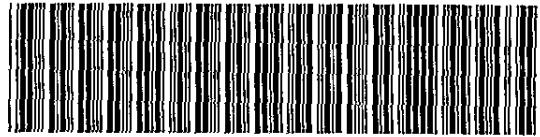

ARTICLES OF INCORPORATION
OF
CIGNAL TRADING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE-ONE

NAME

The Corporate name is **CIGNAL TRADING, INC.**

ARTICLE-TWO

REGISTERED OFFICE

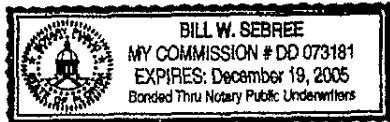




