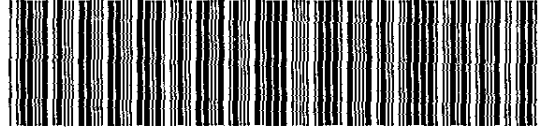

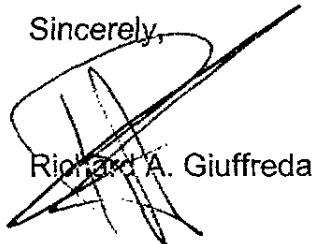

**ARTICLE I
CORPORATE NAME**

The name of this Corporation is BETTER CARE SERVICES, INC.

**ARTICLE II
DURATION**

This Corporation shall have perpetual existence, and shall commence on the date of the execution and acknowledgment of these Articles of Incorporation.

**ARTICLE III
PURPOSE**

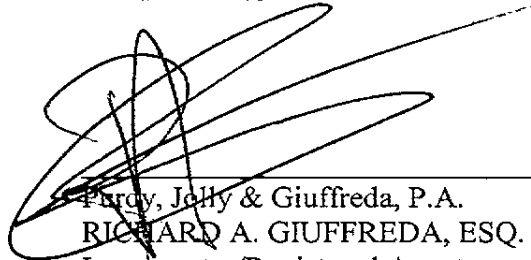
