# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation is Karen A. Dunn, P.A.

# ARTICLE II

The duration of the corporation is perpetual.

### ARTICLE III

The corporation may engage in each and every aspect of the Real Estate profession, but only through its officers, employees and agents who are duly licensed of otherwise legally authorized to render such professional services; and engage in any and every activity permitted from time to time for a corporation so formed to engage in.

# ARTICLE IV

The amount of capital stock of this corporation shall be ONE HUNDRED SHARES (100) at One Dollars (\$1.00) par value stock, which stock shall be non-assessable to be held, sold and paid for at such time and in such manner as the Board of Directors may, from time to time, determine. The principal place for the transaction of its business shall be 2345 Magnolia Lane #12, Naples, Florida 34112. That said corporation shall have the authority to do business at such other place or places within or without the State of Florida, as the corporation may be resolution designate.
