ARTICLES OF INCORPORATION

OF

CENTER STAGE ATTRACTIONS, INC.

ARTICLE I

CORPORATE NAME

The name of this Corporation is CENTER STAGE ATTRACTIONS, INC.

ARTICLE II

DURATION

This Corporation shall have perpetual existence, and shall commence on the date of the execution and acknowledgment of these Articles of Incorporation.

ARTICLE III

PURPOSE
